We are a coalition of local groups, with a working umbrella name of Colorado No More Prisons. The groups involved, at this time, are; DenverABC, Denver Black and Pink, Denver IWOC- a committee of the IWW, ARWG- a working group affiliated with the General Defence Committee of the IWW, focusing on Colorado facilities.

The current situation for prisoners in the Prison Industrial Slave Complex facilities has been exacerbated by the pandemic, caused by the Covid-19 virus. Ongoing deadly conditions for prisoners are now made worse by no communication from the slave masters, except to announce on their websites that visitation has been suspended- no more family visits, no more lawyer visits, nothing.
